- **A.** Unable to provide timeline, given the process is biologically driven. Given the variables, and the to allow evaluation of success of variable changes. Continue to adjust variables individually to find optimal environment.
- **Q.** Is the new flare operational?
- A. The new/enclosed flare is operational when dispersion conditions of the flare emissions are optimal as per the previous open flare operational protocol, as the landfill gas is not "clean. When the new/enclosed flare is not operational, the landfill gas from the scrubber outlet, is recirculated back into the landfill. No H2S is held onsite. The H2S coming out of solution from the leachate within the leachate storage tank, has reduced significantly, however, SBI still running the headspace extraction and filtration system as a safe guard.

#### 8. COMMUNITY FEEDBACK

- **a.** Member voiced concern with the length of time taken by EPA to approve the scrubbers and flare. Submitted August 2023, last submission by SBI 20<sup>th</sup> July 2024 and no further action since. Messages being passed on to SBI during EPA site inspections without formal communication by EPA permissions team. Requested timeline on response to get this operational EPA will escalate internally.
- b. Clarification on WRRF (Transfer station) permissions. Change of legislation June 2021 required SBI to apply for permission for WRRF, even though the activity predated the legislation change, EPA advice was given, as an A13b permit, which was applied for by SBI and granted by EPA. EPA revised their position and advised an A13a was required. This application was submitted by SBI and later withdrawn by EPA. The exemption is from a development licence because SBI were already operating a facility when the legislation changed. Now this exemption is granted, the submission for an A13A licence can be resubmitted.
- **c.** Suggestion to have statement on FAQs re: arson attacks being quelled should be removed may have been seen by offenders as a challenge.

#### 7. REGULATORY UPDATE re City of Casey

- a. Questions raised with Council in the previous meeting, were taken on notice, with detailed responses promptly provided to SBI for submission to the CCC, however, in error, these responses were not forwarded on by SBI. To this end, please find Council's response to the community raised questions:
- Q What is Council's position in allowing a business to continue to operate if it is continually, for more than 2 years in breach of its permitted use?
- A Council has initiated reasonable and proportionate compliance measures for alleged contraventions of Planning Permit PlnA00857/07 (formerly P638/07). Those measures include accountability of each owner and corporate occupier of the land, in line with the Planning and Environment Act 1987 and relevant case law precedence.

Based upon legal advice, Council has made the decision to abstain from any enforcement measures concerning odour or dust emissions from the site. Council recognises that EPA Victoria are the lead agency and best placed for those types of issues and whilst Council actions might be well meaning, those same actions may unwittingly do harm to EPA's current legal proceedings.

Council has at all times and continues to work collaboratively with EPA Victoria providing material support upon their request.

- Q How can the City of Casey allow the construction of Cell 2 when Cell 1 has not been managed to stop odour?
- A Council's jurisdiction does not extend to providing consent or otherwise regulate each of the cells. The consent and compliance process concerning current, future, or proposed cells are regulated by EPA Victoria.

- A General operational activities provide no tangible benefit to the community, and as such will not be disseminated.
- **Q** How much groundwater is extracted from SBI site?
- A General operational activities provide no tangible benefit to the community, and as such will not be disseminated. Suffice to say, SBI operate within the permitted framework.
- **Q** Dust results 3 values provided. What do they mean?
- A In the interest of transparency and collaboration SBI have arrived at a decision regarding specialist assessments, which is, report findings will be summarized and published, with regard to the potential risk posed to human health and the environment.

#### b. Odour Reports

- SBI generated graph showing odour survey outcomes conducted by SBI, against EPA informed reporting incidences. The graph has been updated to include instances when SBI concur with EPA on offsite odour.
- o SBI observed landfill odour during offsite inspections with EPA attributing the flare as the odour source, as confirmed upon shut down of flare and repeat odour observation 15-20 mins post shut down reporting zero landfill odour, by both EPA and SBI.
- The operation of the existing flare remains operational in accordance with the SBI LFG Management Protocol, which sees the flare shut down when wind conditions are insufficient for optimal dispersion of emissions.
- o Recent wind forecasts see the flare shut down more often than not, at close of business.
- Noise Assessment issued to EPA Monday 27 May 2024
  - Risk of harm considered low given noise emission less than or similar to prevailing ambient noise in the area; and
  - Operating times limited to the day period.
- Dust sampling and analysis April 2024, report issued to EPA 28 May 2024
  - Inhalable Dust Concentration at 3 locations below Worksafe Australia exposure limits
  - Crystalline Silica Concentration at 3 locations all under APAC guideline limit

- **Q** When was dust monitoring completed, frequency and coverage.
- A Over a regular shift, while concrete crushing was active, and the prior three days were rain-free. noise over one week.
- **Q** Does the dust analysis include respirable silica?
- A Yes
- **Q** Is the noise monitoring being done in accordance with EPA guidelines?.

- A Yes
- Q Is the new chair going to be a member of the CCC or independent?
- A Independent, similar to previous external facilitator.
- **Q** There are still noise complaints, including some alleging operations prior to 7am.
- A SBI operates in accordance with our council permitted hours ONLY. EPA and Council have overlapping legislation and regulatory powers. EPA tend to focus on noise levels and Council on operational hours.
- Q Is there anything that can done to expediate ESV signoff?
- A No, in the midst of specialist inspections and signoff, prior to ESV.
- Q How long does EPA have to approve or decline in regard to scrubbers/flare?
- A EPA can't confirm but will follow up, and Permissions haev been informed about the critical timeline of the project (ACTION ITEM item by EPA).
- Q Community reports increased over the last few months and have more recently reduced, i have there been any change in SBI operations or processes to trigger this spike?
- A Nothing at SBI has changed. Systems checked multiple times per day, onsite personnel 5.5 days a week in addition to fulltime onsite caretaker. Several full-time staff visit outside of normal operating hours to ensure all systems are operating as required. especially over closure periods. No change to processes and/or protocols.
- **Q** Update from EPA on pollution reports.
- A The EPA IT team are working on the changes to the online reporting system unclear as to when reports will resume being forwarded to SBI. In the interim, EPA will give SBI the monthly numbers of reports received that list SBI as the odour source. Reports that are greater than 10km away from SBI are most likely an alternate source, however the report is still counted against SBI. EPA are working on alternate odour sources as well as improved reporting systems.
